Chairwoman Carla JeanBatiste asked for public comments regarding the proposed ordinances being considered for final adoption.

Deputy Clerk of the Council Chantelle Dever read each Ordinance Summary.

Chairwoman Carla JeanBatiste stated Ordinance Summary No. 1395-OR {An Ordinance setting the speed limit to 15 mph on Boudreaux Road, located in District 2.} was proposed because speed limit signs were placed on the road, and an Ordinance had not been passed to do so.

Councilman Chris Tauzin explained Ordinance Summary No. 1396-OR {An Ordinance setting the speed limit to 15 mph on Catahoula Park Road, located in District 5.} was proposed because speed limit signs were placed on the road, and an Ordinance had not been passed to do so.

Parish President Chester Cedars discussed Ordinance Summary No. 1398-OR {An Ordinance authorizing St. Martin Parish Government to abandon certain streets which were subject to an Act of Dedication in 1979, which Dedication was never accepted by the Parish; the said streets being depicted on a plat of survey recorded in Book 796, Page 519, under Entry Number 189187 of the Conveyance Records of St. Martin Parish, Louisiana.}. President Cedars mentioned the Parish has never accepted formally, informally, or otherwise any of the roads in question and has never performed any sort of maintenance of such roads.

Director of Planning & Zoning Morgan Allemond asked if anyone had any questions on Ordinance Summary No. 1399-OR {An Ordinance amending Chapter 19, St. Martin Parish Zoning Ordinance, Appendix D, Parish Road Zoning Data Sheets of the Code of Ordinances for the St. Martin Parish Government by: amending the zoning classification district on a portion of a road

zoned in the original ordinance adopted on December 18, 1995. {1020 Jolie Blonde Road}}. She stated that nothing has changed since this was first presented, nor has she received any calls regarding this rezoning request.

Parish President Chester Cedars explained the amendments made to Ordinance Summary No. 1401-OR {An Ordinance to amend and/or revise Section 1 of Article II of the St. Martin Parish Zoning Ordinance relative to the definition of "Home Occupation," and to provide for all matters associated therewith.} are relative to remote/internet transactions which did not exist in 1995 when the Zoning Ordinance was originally adopted.

Upon requesting and hearing no further comments from the audience regarding the proposed ordinances being considered for final adoption, the Chairwoman requested a motion to close the Public Hearing.

AN ORDINANCE AUTHORIZING ST. MARTIN PARISH GOVERNMENT TO ABANDON CERTAIN STREETS WHICH WERE SUBJECT TO AN ACT OF DEDICATION IN 1979, WHICH DEDICATION WAS NEVER ACCEPTED BY THE PARISH; THE SAID STREETS BEING DEPICTED ON A PLAT OF SURVEY RECORDED IN BOOK 796, PAGE 519, UNDER ENTRY NUMBER 189187 OF THE CONVEYANCE RECORDS OF ST. MARTIN PARISH, LOUISIANA.

WHEREAS, on July 9, 1979, Raymond Victor Foti did cause to be created and recorded certain Restrictive Covenants for St. James Subdivision (Phase II) by Act No. 189187 of the Conveyance Records of St. Martin Parish in Book 796, at page 519; and

WHEREAS, this filing contained a plat of survey by Charles A. Fuselier & Company dated January 30, 1979, which showed streets named Rose Drive, North Chuck Drive and a portion of West Chuck Drive, which streets according to said plat adjoin Lots 1 through 36, and also adjoin Lots 54 through 57 of said subdivision; and

WHEREAS, the said streets and the said lots, as depicted on the aforesaid plat of survey were never constructed or developed; and

WHEREAS, St. Martin Parish Government ("Parish") never formally accepted the dedication of said streets, nor has the Parish ever maintained or improved any portion of said streets; and

WHEREAS, there is purported authority for the proposition that the filing alone, without acceptance, served as a legal dedication of said streets; and

WHEREAS, the law is clear that the Parish has no liability whatsoever with respect to said streets, since it never formally accepted the dedication; and

WHEREAS, the current owner of the property shown on the plat, inclusive of the streets and lots previously referenced herein has requested that St. Martin Parish abandon any legal dedication of said streets, to clear the title to the land thereunder; and

WHEREAS, the St. Martin Parish Council has determined that the subject property no longer serves any public purpose whatsoever and is not being used, nor has it ever been used, by the general public as a road/street or for any other purpose; and

WHEREAS, the Parish Council finds that no cost has been incurred by the Parish with respect to the dedication; and

WHEREAS, the Parish Council finds that the dedication, if lawful, presents no benefit and has no value to the Parish; and

WHEREAS, the Parish Council believes that it will benefit by severing all connection between the Parish and said streets, and therefore is willing to execute an abandonment of said streets:

BE IT, THEREFORE, ORDAINED by the St. Martin Parish Council that the Parish President, Chester R. Cedars, (or his successor in office), be and is hereby authorized, directed and empowered to execute an act on behalf of the Parish, abandoning any interest which the Parish had, has or may have in the following described property situated in St. Martin Parish, Louisiana:

Those certain streets adjoining Lots 1 through 36, and also adjoining Lots 54 through 57 on that plat of survey by Charles A. Fuselier & Co., dated January 30, 1979 which is attached to Restrictive Covenants for St. James Subdivision (Phase II) recorded on July 9, 1979 in Act No. 189187 of the Conveyance Records of St. Martin Parish in Book 796, at Page 519, and which are identified on said plat of survey as Rose Drive, North Chuck Drive and part of West Chuck Drive.

BE IT FURTHER ORDAINED, that the Parish does hereby formally, and irrevocably, abandon and/or renounce any rights which it may have acquired by virtue of the purported dedication of the streets described above.

BE IT FURTHER ORDAINED that the provisions of this Ordinance are hereby declared to be severable, and if any provision, word, phrase, or clause of this Ordinance, or the application thereof to any person or circumstance is held invalid, such invalidity shall not effect the validity of the remaining portions thereof.

BE IT FURTHER ORDAINED that all Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

BE IT FURTHER ORDAINED this Ordinance shall become effective immediately upon approval of the St. Martin Parish Council and the signature of the Parish President.

AN ORDINANCE TO AMEND CHAPTER 19, ST. MARTIN PARISH ZONING ORDINANCE, APPENDIX D, PARISH ROAD ZONING DATA SHEETS OF THE CODE OF ORDINANCES FOR THE ST. MARTIN PARISH GOVERNMENT BY: AMENDING ZONING CLASSIFICATION DISTRICT ON A PORTION OF A ROAD ZONED IN THE ORIGINAL ORDINANCE ADOPTED ON DECEMBER 18, 1995. {1020 JOLIE BLONDE ROAD}

The Parish Council of the Parish of St. Martin does hereby ordain as follows:

SECTION I: The Parish Road Zoning Data Sheets are hereby amended to change the zoning classification district on a portion of the parish road listed below and to allow the remainder of the road to remain as classified.

<u>Road</u>	Old Zoning Classification	New Zoning Classification
Jolie Blonde Road	R-2	C-2
(1020)	(Mixed Residential)	(General Commercial)

This zoning classification change is being made to allow for the operation of selling firearms with a Federal Firearms License Class I at 1020 Jolie Blonde Road, Breaux Bridge, Louisiana, Assessor's Parcel No. 06002C0620. If a change in this type of business is desired in the future, the change would have to be approved by the Parish Council in the form of an amended ordinance. This zoning classification shall remain in effect only so long as the subject property remains owned by Shane and/or Kimberly Thibodeaux. Once the business is closed or the property is sold, the zoning

classification will automatically revert back to the old zoning classification of R-2 (Mixed Residential).

BE IT FURTHER ORDAINED that the use of the said property for the purposes defined by Appendix A of the St. Martin Parish Zoning Ordinances relative to the C-2 classification are hereby restricted as follows:

- A. The zoning change shall remain in effect only so long as the subject property remains owned by Shane and/or Kimberly Thibodeaux. Therefore, if the property is sold and/or transferred into another party's name, the new owner may not conduct business at the said property of 1020 Jolie Blonde Road, Breaux Bridge, Louisiana.
- B. The zoning classification of C-2 (General Commercial) would revert to R-2 (Mixed Residential) if the property of 1020 Jolie Blonde Road would transfer ownership.
- C. There shall be no storefront, nor any advertising at the address of 1020 Jolie Blonde Road, Breaux Bridge, Louisiana.

ORDINANCE NO. 23-07-1401-OR

AN ORDINANCE TO AMEND AND/OR REVISE SECTION 1 OF ARTICLE II OF THE ST. MARTIN PARISH ZONING ORDINANCE RELATIVE TO THE DEFINITION OF "HOME OCCUPATION," AND TO PROVIDE FOR ALL MATTERS ASSOCIATED THEREWITH.

WHEREAS, the St. Martin Parish Government has determined that its current zoning ordinance should be revised in order to address outdated and potentially ambiguous provisions in Section 1 of Article II of its Zoning Ordinance relative to the definition of "Home Occupation"; and

WHEREAS, the amendment and revisions hereinafter effected will allow a more reliable and cogent application of the rules and principles which govern the Parish's zoning regulations:

BE IT THEREFORE ORDAINED that Section 1 of Article II of the Zoning Ordinance of St. Martin Parish be and is hereby amended, revised, enacted, and/or reenacted as regards the definition of Home Occupation as follows:

Home Occupation: An accessory use of a service character customarily conducted within a dwelling by a resident thereof, which is clearly secondary to the use of the dwelling for living purposes and does not change the character thereof or have any exterior evidence of such secondary use other than a small nameplate and in connection therewith there is not involved the keeping of stock-in-trade. The office of a physician, surgeon, dentist, or other professional engaged in the purchase or sale of economic goods, including violin, piano, or other professional musical instrument instruction limited to a single pupil at a time, shall be deemed to be a home occupation; and the occupations of a dressmaker, milliner, seamstress or beauty parlor, each with not more than one (1) paid assistant, shall also be deemed a home occupation. The following shall not be deemed home occupations: dancing instructions, band instrument instruction in groups, tearooms, tourist homes, real estate offices, convalescent homes, mortuary establishments and stores, trades, or businesses of any kind not herein specifically excepted.

Home Occupation shall also mean, to the extent not otherwise specified in the foregoing paragraph, any accessory use which embraces either the remote or internet sale of items or the storage of items used by a resident of the principal dwelling solely for the purposes of off-site rental or other use provided that in either instance there is no business activity conducted at the site of the dwelling such as clientele or customer visitation for the purpose of shopping or selection of items. The storage of such items shall be clearly secondary to the use of the dwelling for residential or living purposes and must not alter the character thereof or have any exterior evidence of such secondary use other than a small nameplate and/or the temporary cleaning or inspection of the items solely by an adult resident of the dwelling.

BE IT FURTHER ORDAINED that all Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

BE IT FURTHER ORDAINED that should any clause or provision of this ordinance, or the application thereof to any person or circumstance, be deemed invalid or unenforceable for any reason, then such invalidity shall not affect the remaining portions of this edict which can be afforded legal efficacy with the invalid provision or application, and to end, the provisions of this Ordinance are hereby declared severable.

A RESOLUTION AUTHORIZING PARISH PRESIDENT CHESTER CEDARS TO ENTER INTO A LAND SERVICES AGREEMENT WITH ANGELLE & DONOHUE FOR THE CYPRESS BAYOU/COULEE LASALLE DRAINAGE IMPROVEMENTS PROJECT.

WHEREAS, St. Martin Parish Government has sold twenty million dollars of general obligation bonds dedicated specifically to address the mitigation of flooding issues which were exposed in part by the floods of 2016 and in preparation for future storm events; and

WHEREAS, one of the projects developed by the St. Martin Parish Government is the clearing and cleaning of channels known as "Cypress Bayou/Coulee LaSalle" together with the

replacement of structure known as the Hughes Road Bridge; and

WHEREAS, in connection with the Louisiana Watershed Initiative, St. Martin Parish has been awarded one million dollars for this project as part of a regional grant program for drainage projects; and

WHEREAS, St. Martin Parish Government has committed the sum of three million dollars for the aforementioned project; and

WHEREAS, Seller's and Associates, Inc. has recommended St. Martin Parish Government enter into a Land Services Agreement with Angelle & Donohue to provide for the Cypress Bayou/Coulee LaSalle Drainage Improvements Project's servitude acquisition, on an as needed basis; and

WHEREAS, the confection of this agreement will not change St. Martin Parish Government's monetary commitment amount.

NOW, THEREFORE, BE IT RESOLVED that the St. Martin Parish Council does hereby authorize, direct and empower the Parish President to execute a Land Services Agreement with Angelle & Donohue for the Cypress Bayou/Coulee LaSalle Drainage Improvements Project.

MARTIN PARISH GOVERNMENT TO JOIN THE ATTORNEY GENERAL OF LOUISIANA AS A PARTY PLAINTIFF IN LITIGATION AGAINST THE FEDERAL EMERGENCY MANAGEMENT AGENCY ("FEMA"), THE LITIGATION CHALLENGING RISK RATING 2.0 RELATIVE TO ITS METHODOLOGY IN DETERMINING FLOOD RISKS AND RATES FOR FLOOD INSURANCE, IT BEING UNDERSTOOD THAT COUNSEL FOR ST. MARTIN PARISH SHALL BE THE ATTORNEY GENERAL FOR THE STATE OF LOUISIANA.

WHEREAS, the Federal Emergency Management Agency ("FEMA") is updating the National Flood Insurance Program's (NFIP) risk rating methodology through the implementation of a new pricing methodology, titled "Risk Rating 2.0: Equity in Action;" and

WHEREAS, FEMA states that Risk Rating 2.0's "methodology leverages industry best practices and cutting-edge technology to enable FEMA to deliver rates that are actuarily sound, equitable, easier to understand and better reflect a property's flood risk"; and

WHEREAS, the Association of Levee Boards of Louisiana, members of both the Louisiana legislature and the federal legislature, members of state government, numerous Parish Presidents and their Councils, and many other entities in Louisiana and around the nation have grave concerns about the soundness of Risk Rating 2.0's underlying methodology, its failure to properly take into account any of the numerous improvements Louisiana's Levee Boards have made to the flood protection systems, and its catastrophic effect on Louisiana's flood insurance rates and the ability of Louisiana's homeowners to purchase flood insurance; and

WHEREAS, many of those entities have repeatedly raised their concerns to FEMA, have asked FEMA for documentation showing FEMA's underlying methodology, and have been passed from one federal office to the next without receiving any meaningful answers to their questions or documents showing FEMA's underlying methodology; and

WHEREAS, FEMA has denied and continues to deny the efforts of those who are trying to protect their interests, the interests of their members, the interests of many Louisiana industries, and the interests of Louisiana citizens, making what is supposed to be "Equity in Action" an inequitable program across the entire State of Louisiana:

NOW, THEREFORE, BE IT RESOLVED that St. Martin Parish Government, acting through its governing authority, joins the Attorney General of Louisiana in litigation against FEMA to challenge Risk Rating 2.0.

WHEREAS, the Town of Arnaudville, Louisiana ("Arnaudville") has both the desire and capacity to maintain, manage and operate the Pavilion; and

WHEREAS, St. Martin Parish Government postulates that the maximum possible results would accrue to an arrangement under which the Town of Arnaudville is able to maintain, manage, operate and control the facility; and

WHEREAS, the parties agree that the most appropriate vehicle to consummate the agreement between the parties is an Intergovernmental Agreement as authorized by the Louisiana Constitution:
